Registration opens on dogshow.ca on March 9th at 9 a.m.

Registrations close at 11:59 p.m. 2 Mondays before the event or when the limit is reached.

LOCATION AND SPECIFICATIONS

- This test will be held at GUIDES CANINS 1200A montée Poirier, Saint-Lazare, outdoors
- https://www.guidescanins.com/en/facilities/#directions
- Lodging & food accommodation: https://www.guidescanins.com/en/ under the Trial section.
- The event will take place rain or shine. Field conditions: sand track, not fenced, away from road.
 Equipment used: Continuous loop lure with plastic bags.
- It will be held according to the regulations and sanctioned by the Canadian Kennel Club (CKC).

ELIGIBILITY

- SPRINTER participation is open to all purebred and mixed breed dogs at least 12 months of age that
 are individually registered with the CKC; or have an Event Registration Number (ERN); or have a
 Performance Event Number (PEN); or eligible for registration with the CKC; or have a Miscellaneous
 Certificate Number (MCN) if it belongs to a CKC listed breed; or have a Canine Companion Number
 (CCN) if it's a mixed breed
- Dogs that are foreign-born and owned who enter Canada for the sole purpose of competing in CKC events do not require a CKC registration number, but do require an Event Registration Number (ERN).
 This must be applied for within 30 days of entering a CKC event.
- An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the award/titles earned, the non-member will have the choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be canceled. These fees apply only for dogs wholly owned by non-CKC members and are not applicable to CKC members.

REGISTRATION, FEES & PAYMENTS

- Competitors, through the submission of entries, acknowledge that they know the CKC rules. www.ckc.ca.
- Entries are limited. We reserve the right to refuse any entry. The runs are limited to 75 competitors per event, if the schedule allows 'Stand-by' or day of additions will be allowed.
- In the event that the entry limit is reached before the official closing date, an Alternate List will be
- compiled in the order received. Alternate dogs will be allowed to run in the place of any absent dogs.
- A dog may enter only once per event. Dogs run as singles.
- Each sprint will cost \$29+tx/run before the closing date.
- It will be possible to register after the closing date, if there is still room. The cost for late entries will be \$38 +tx/run
- The price for listed dogs will be: \$ 10.50/run

- There will be a \$20.00/run fine for a loose dog on the track while a run is in progress.
- For Exhibition Only (FEO) entries are not accepted.
- Females in season and dogs in poor body condition cannot enter. Females in heat are not allowed on the competition site during the competition.
- Dogs that miss roll call will not be allowed to run and their entry fee will not be refunded. Handlers
 must use a leash to bring their dogs to the start line. Muzzles can be used. If a muzzle is not available
 two people can be used to catch the dog. The dogs can wear a flat collar with no tags.
- There shall be no refunds, cancellation or changes after the closing date or in the event a dog and/or handler are dismissed from competition regardless of the reason for such a dismissal or in the event of inclement weather.
- Participants canceling before the closing date will obtain a refund.
- Bitches in heat will run at the end of the day and must wear panties.
- A refund will be issued for dogs and/or handlers that are injured, providing that they send a doctor or
 a veterinarian note and that the trial secretary is advised at least 24 hours before the time of the
 registration of the first day of the test.
- Any refund issued will be minus a 10% administrative fee.
- A \$20 fee will be charged for NSF checks and refused credit cards.

PROCEDURE

- An email with general instructions and running orders will be sent the Wednesday before the event
- Handlers need to arrange for a releaser and a catcher; bring a friend, or ask another handler to help each other. If your dog is very strong and has intense prey drive, you may want to bring 2 friends.
- This sprinter event will be on a 'run-card' running order, before each run the dog must pass through 'roll call' to verify that they are not injured. This will be based on a first come first serve basis. A minimum of 3 dogs must be placed between each run (dogs CANNOT run back to back in order to avoid injury).
- Upon arrival at the competition, you will receive your scorecards. While following the pre-established schedule, you will check in at the ring and sign up on the running order board.
- All names must be put onto the board before 5 p.m. to ensure that we have enough time to get through everyone. Dogs not on the board before 5 p.m. will not be allowed to run.
- A lunch break will take place at noon each day.
- Ribbons will be given out at the end of each run with the points on the back. Title ribbons will be awarded for each title for Event. Please let us know if a title is a possibility for you!
- The results will be posted on site and sent by email at the end of the day.
- Results will be published on site and also on the website, as soon as possible at the end of the events.
